- Payment may be made by cash, Zelle, Apple Pay, or PayPal (3% surcharge applies).
- Adopting Individual and OpalOnyx Dalmatians do hereby agree to the purchase and sale of the above-described Dog for the purpose of a pet quality companion dog. It may never be used for breeding and must be Neutered/Spayed. If the Dog is not sterilized already the new owner agrees to spay/neuter this Dog as soon as possible.
 - IN case this dog is not sterilized, Opalonyx Dalmatians, will retain the Registration (s) until proof of spaying/neutering is provided. This proof must contain the name and contact information of the veterinarian, clinic and dates of the procedure. Once proof is provided, Opalonyx Dalmatians will release the Registration (s) of the Dog to the Adopting Individual to be transferred.
- All sales are considered final on the delivery of the Dog. No refund of the adoption fee shall be made thereafter.
- As of the date of adoption the Dog is guaranteed to be in good health and free of communicable diseases unless otherwise specified here. Immunizations are current and a veterinarian record will be provided to the Adopting Individual.
- OpalOnyx Dalmatians will be available for advice in all matters concerning this Dog throughout its lifespan.
- To ensure that Adopting Individual does not euthanize the Dog or take it to an animal shelter, Adopting Individual will take the Dog back at any time during the Dog's lifetime. OpalOnyx Dalmatians will not issue a refund or provide another Dog to Adopting Individual.
- Adopting Individual agrees to promote the maintenance of this Dog's health and well-being by providing regular veterinarian care, vaccinations as required by law and recommend by the Adopting Individual's veterinarian. Adopting Individual will also provide the Dog with a breed appropriate diet, hydration and exercise to promote good health, development and lifelong prevention of urinary urate stone formation.
- Adopting Individual agrees that this Dog is a house dog and will not be chained or tethered outside and will be hand walked or allowed to exercise within a fenced yard. It will never be allowed to run free off the owner's property or beyond the owner's control. It will not be crated for long periods of time without an opportunity to relieve itself.
- Adopting individual agrees that this Dog shall NEVER be abandoned to an animal shelter, used as a guard dog or attack/protection trained.

11. Adopting Individual agrees that neither the Buyer nor the Buyer’s estate/executors may sell this Dog or transfer ownership of this Dog. In the event that the Adopting Individual, or his/her estate can no longer maintain this Dog for any reason, it must be returned to OpalOnyx Dalmatians unless OpalOnyx Dalmatians otherwise approves in writing of an alternative placement.
12. Adopting Individual and OpalOnyx Dalmatians will notify each other of any change of address and /or contact information throughout this Dog’s lifespan.
13. Adopting Individual is not acting as agent for any other person or business in the purchase of the Dog.
14. Adopting Individual will not sell, give, or release the Dog to a pet shop, retail store, dog dealer, animal testing facility, research facility, or an agent for any such business or facility.
15. From the date of possession or delivery of the Dog, Adopting Individual is responsible for all related expenses/bills including but not limited to: Health, Veterinary, Day/Night Care and Maintenance.

Indemnity and Release

If any action or failure to act on the part of The Adopting Individual shall result in any claim, suit, loss, damage, injury, death, or liability, Buyer agrees to defend, indemnify, and hold OpalOnyx Dalmatians harmless and to pay all of OpalOnyx Dalmatians’ costs and expenses, including reasonable legal fees, any amount paid in settlement and any award or judgment with respect thereto. Adopting Individual releases OpalOnyx Dalmatians from any and all liability, costs or damages caused by the Dog after placement with Adopting Individual, including but not limited to damage to or destruction of property, and injury to any person.

Entire Agreement

This Agreement represents the entire agreement between the parties. OpalOnyx Dalmatians and Adopting Individual have made no other agreements, promises, representations or warranties, express or implied, unless specifically stated in this Agreement. OpalOnyx Dalmatians and Adopting Individual agree to submit to the jurisdiction of State of Florida, Levy County in any action arising out of or relating to this contract.
