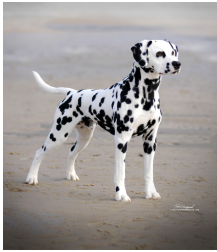

1. This puppy is sold exclusively as a companion only on limited registration and is to be spayed or neutered per the terms of this contract.

2. Each Troika Dalmatian puppy is guaranteed to be in good health at the time of this sale and for 5 days thereafter. The Buyer will be given a complete record of all inoculations and wormings done prior to the sale. This Dalmatian puppy has been BAER hearing tested by a veterinarian and is guaranteed to hear _____ **. The Seller attests that the temperament of this puppy at the time of sale is sound and outgoing. It is required that this Dalmatian puppy be examined by the Buyer' veterinarian within 5 days.** Should any serious illness be found at that time, upon written certification from two concurring veterinarians,

this Dalmatian may be returned for a refund of the full purchase price paid by Buyer. However, Seller is not responsible for injuries or broken bones occurring after the Dalmatian leave the Seller's premises. After this 5 -day period, this dog is the sole responsibility of the Buyer with the exception as noted in Paragraph 2 below.

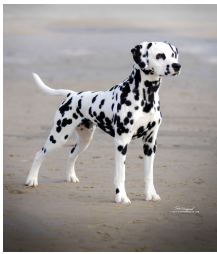
3. Buyer will be provided with 4-generation pedigree and properly completed AKC registration papers.
4. Buyer agree to love, honor and cherish this Dalmatian; to keeps its general welfare a primary concern; to provide indoor housing, a suitable crate, a fenced yard or exercise area, appropriate positive obedience training, and protection from harm. This Dalmatian is understood to be a house-dog that will not be left out in the weather. Buyer understand the Dalmatian's requirement for daily exercise to be a condition for physical and mental well-being, and agree to set aside the time necessary for this exercise. Buyer will be responsible for the care, proper feeding, licensing, boarding, and health and veterinary needs, including but not limited to, all primary as well as annual vaccinations and heartworm testing. Buyer acknowledge that from the day of purchase, environment, that is socialization and nurturing are key to the puppy's continued healthy development and integration into the human world and is the responsibility of the Buyer.
5. This Dalmatian is guaranteed to be free of hereditary crippling and/or disabling defects visible by 18 months of age. Determination of what constitutes a hereditary defect is to be by the unanimous agreement of two (2) veterinarians agreeable to both parties. One of these veterinarians is to be a tenured faculty member of an accredited university veterinary teaching hospital or Board-certified in the applicable specialty. If hereditary defect is found within the aforesaid parameters, the following remedy applies:

100% refund of the purchase price provided the living Dalmatian and its registration papers are returned to Seller.

6. **If Buyer should ever decide, for whatever reason, that they can no longer keep this Dalmatian or if they should be unable to fulfill the other terms of this contract, the dog must be returned to Seller in the event no other suitable placement is available. In any case, Seller must be consulted as to the disposition of the dog. The relinquishment of any Dalmatian and its papers to the Seller under the terms of this provision automatically voids any controls or interest held by the Buyer.**

8. **Each Dalmatian is sold exclusively as a home companion. Buyer agree to neuter the male Dalmatian no younger than 12 months of age and no older than two years, and to provide the Seller with evidence to that effect. Buyer understands that they will be provided with an AKC Limited Registration, which indicates the AKC status of the puppy, but prevents any progeny being registered should the Buyer choose to disregard this agreement. Damages in the amount of \$1000.00 shall be due to Seller in the event Buyer fails to comply with the requirement to neuter/spay this Dalmatian and/or are unwilling or unable to provide evidence to that effect.**

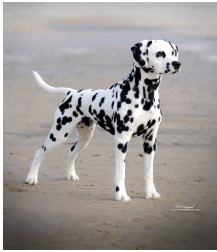
